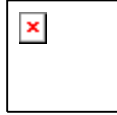

LAW NO. 3 OF 2009

BE IT ENACTED by the Nasarawa State House of Assembly and by the authority of same as follows:

| <p>S1. The Law may be cited as Remuneration of Political and Public Office Holders at the Local government Level/Development Area Law 2009 and shall be deemed to have come into operation on the 7th day of May 2009.</p> | Citation and Commencement. |
| <p>S2. The Local Government/Development Area Political and Public Office Holders listed in the Schedules to this Law shall be paid Annual Basic Salaries and Allowances as specified in the Schedules to this Law.</p> | Salaries and Allowances of Local Government Political and Public Office Holders |
| <p>S3. The remuneration and salaries payable to the office holders as contained in the schedules shall not be altered to their disadvantage after their election or appointment.</p> | No disadvantage alternation after appointment. |
| <p>S4. The Local Government/Development Area Political and Public Office holders shall earn remuneration with effect from the date of assumption of office.</p> | Effective date of payment. |
| <p>S5. The Remuneration of Local Government Political and Public Office Holders in Nasarawa State Law 2001 is hereby repealed.</p> | Repeal. |
