LAW NO. 1 OF 2014

19th February, 2014

Date of Commencement.

Pursuant to the provision of S.7 (1) and (2) of the Area Courts Law of 1968 and Magistrate Courts law it is hereby notified as follows:-

- S. 1. This may be cited as the Upper Area Courts and magistrates Courts (Directive permitting the Holding of sessions elsewhere within their Territorial Jurisdiction) Notice No.1 of 2014 and shall come into effect on the 19th day of February, 2014. Title and Commencement.
- S. 2. An Upper Area Courts and Magistrates Courts is hereby directed that for the purpose of exercising its powers under the Environmental Sanitation Law Notice No. 9 of 1997 of Nasarawa State, it is allowed to hold session at such a place and time (other than a Sunday) convenient for the dispatch of business of the court within the Geographical Zone.
